With reference to the application dated 25.11.2025 and subsequent recommendations of District Educational Officer (Private Schools) **Chennai(Egmore)** and school inspection on 30.04.2026 in this regard, I hereby convey the grant of Recognition to **Green Valley Central School, No. 2, Kalamegam Road, Mugappair west, Ambattur Taluk, Chennai – 600 037, Thiruvallur District, Tamil Nadu** for the class **LKG to XII** Standard for the period up to **01.06.2028** in compliance to Rule 12 of Right of Children to Free and Compulsory Education Act, 2009 and Rules 2011 and maintain the standards and norms as specified in section 19 of the Right of Children to Free and Compulsory Education Act, 2009.

21. The recognition shall be withdrawn if any contravention of the provisions of the Act, Rules or the conditions of recognition are found and proved.
22. The Management shall follow the directions issued by the School Education Department, Government of Tamil Nadu from time to time keeping in view of the safety and security of the children and the overall administration of the school.
23. The school management shall have full responsibility for any court case that may arise. This order may be used only for the purpose of seeking affiliation to **Central Board of Secondary Education** as requested by the management and the management is not entitled to seek affiliation to any other Board without obtaining No Objection Certificate from the School Education Department, Government of Tamil Nadu.
24. It is instructed to construct additional classrooms and provide laboratory facility before applying for the grand of permission for additional sections namely 9 & 10
25. Since the school is located in more than one survey number, there shall be no other educational institution in these survey numbers.
26. Drinking water facility, Toilet Facility and Class room should be provided in accordance with student strength.
27. The classrooms and laboratory should be as per the building plan approval. Any alteration in existing classrooms or creation of additional classrooms should be done with the proper approval of the concerned Authorities.
28. The Number of persons accommodated in the school building should not exceed the number sanctioned in the D- Licence.
